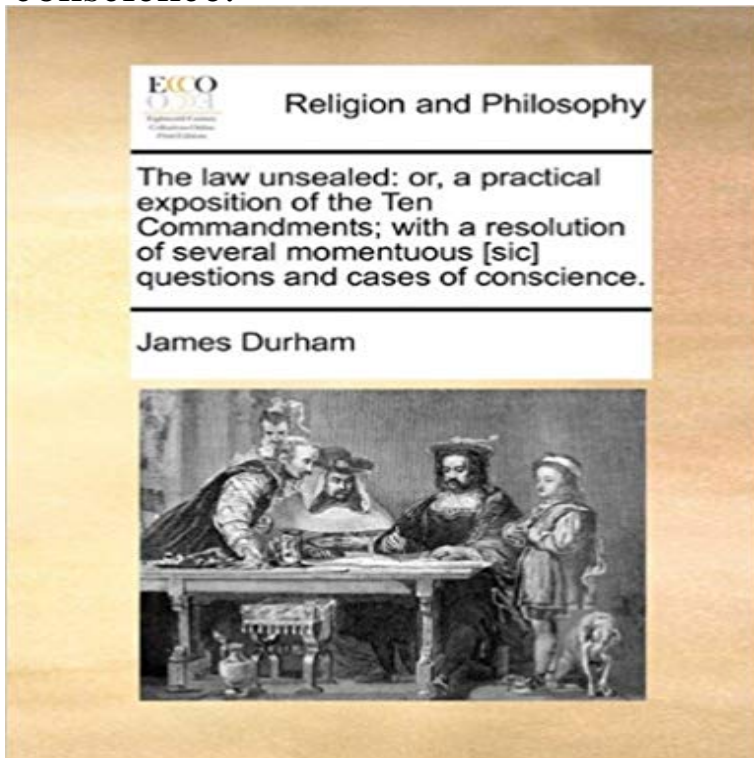


# The law unsealed: or, a practical exposition of the Ten Commandments; with a resolution of several momentuous [sic] questions and cases of conscience.
