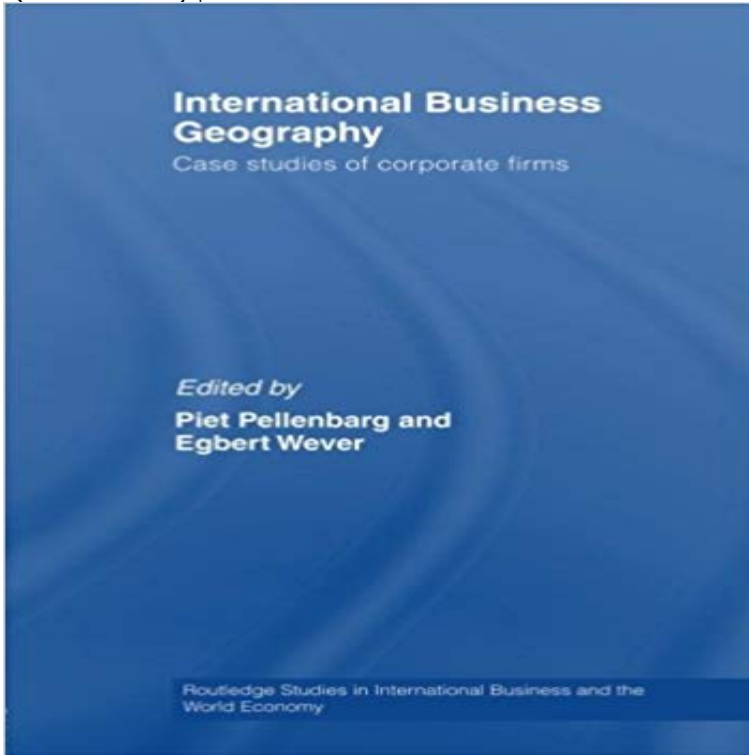


International Business Geography: Case Studies of Corporate Firms (Routledge Studies in International Business and the World Economy)
