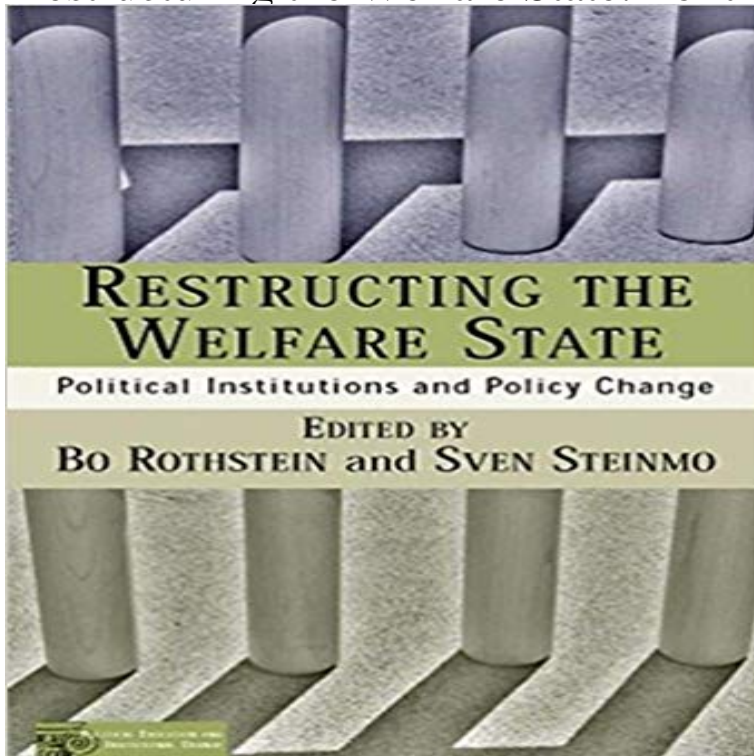


Restructuring the Welfare State: Political Institutions and Policy Change
