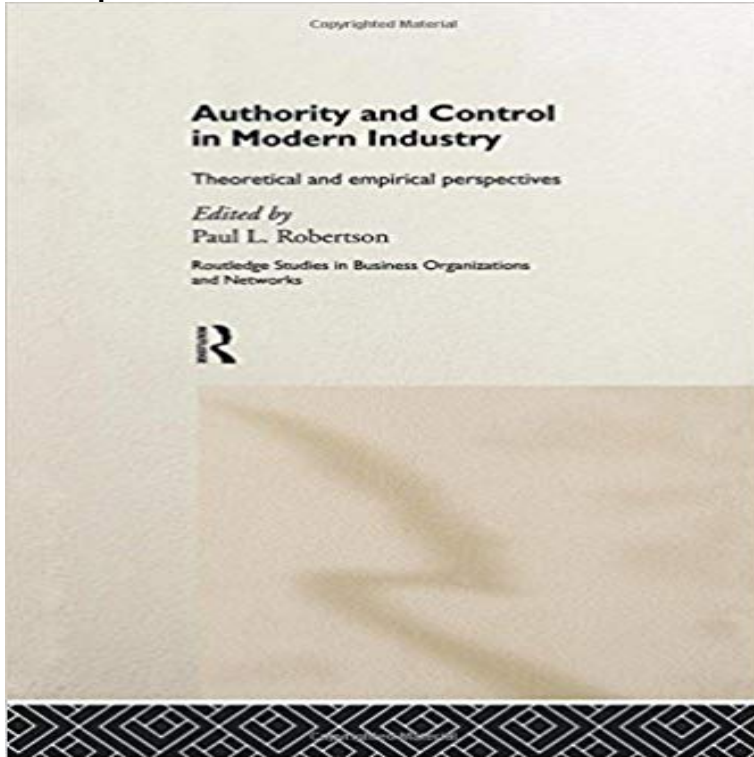


Authority and Control in Modern Industry: Theoretical and Empirical Perspectives
