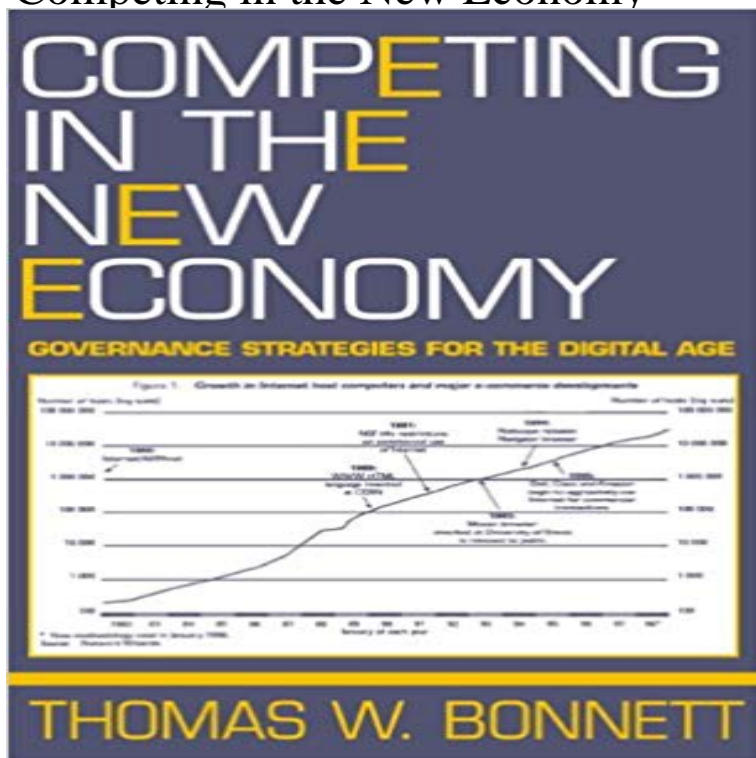


Competing in the New Economy
