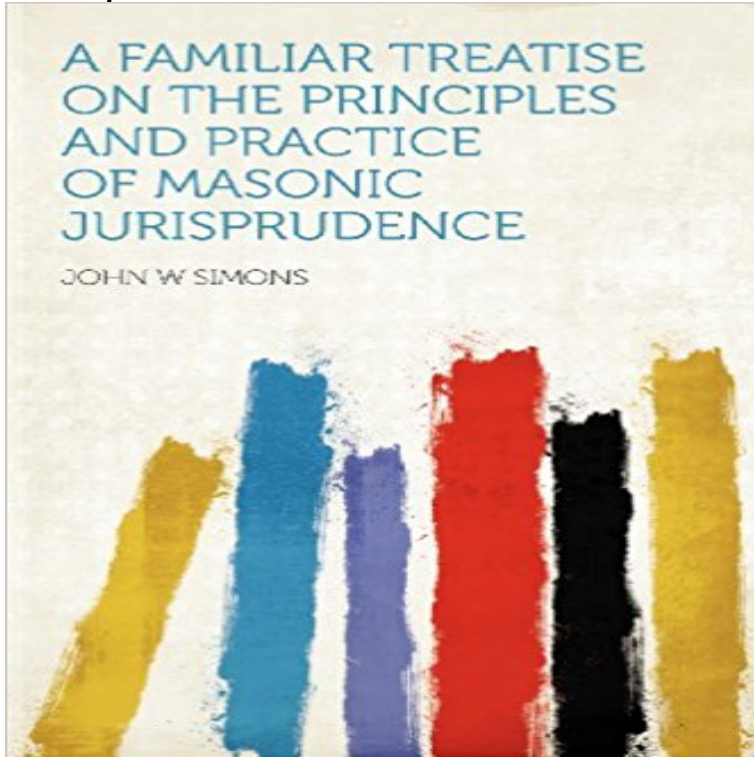


A Familiar Treatise on the Principles and Practice of Masonic Jurisprudence
